## GUIDELINES FOR PH.D. ADMISSIONS FOR EXECUTIVES FROM INDUSTRY/STATE AND CENTRAL GOVT. ORGANIZATIONS/ SCIENTISTS FROM R&D ORGANIZATIONS/PUBLIC SERVANTS

## Eligibility Criteria:

- a. Executives sponsored by the industry having turnover of at least Rs.5.00 Crore per year with a minimum of 5 years experience, working in a Grade equivalent to that of Assistant Professor cadre or above and at least 55% marks/6.0CGPA in Master's Degree in the concerned discipline are eligible for admission to the Ph.D. program (full-time/part-time) in core/interdisciplinary subject.
- b. Executives with at least 55% marks/6.0CGPA in Master's Degree in the concerned discipline and working in the central & State Government organizations/ Central/State Civil Service Officers with at least five years of service in a cadre comparable to that of Assistant Professor cadre or above are eligible for admission to the Ph.D. program (full-time/part-time) in core/interdisciplinary subject.
- c. Scientists/Scientific Officers working in State/National/International research institutes/Organizations in a senior equivalent to that of an Assistant Professor cadre or above with a minimum of five years of experience and at least 55% marks/6.0CGPA in Master's Degree in the concerned discipline are eligible to register themselves in the Ph.D. (full-time/part-time) program.
- d. Member of Parliament (M.P) Member of Legislative Assembly (M.L.A) and Member of Legislative Council (M.L.C) with at least 55% marks/6.0CGPA in Master's Degree in the concerned discipline are eligible for admission into Ph.D. (full-time/part-time) program in the core/interdisciplinary area.

The candidates admitted for Ph.D. have to pay an annual fee of Rs.80, 000 till the date of submission of Ph.D. thesis

## General Guidelines.

- 1. Admissions under this category apply to only constituent colleges/units of JNTUA and Research Centers recognized by JNTUA. However, if a candidate joins in any of the recognized research centers of the University, the fee paid by the candidate will be shared in the ratio of 40:60 between the University and the respective affiliated colleges.
- 2. Admission to the Ph.D. program under the above category shall be taken up once a year.

- 3. It is suggested that the University and Research/Industrial Organization of the candidate shall enter into a Mutual Academic Agreement to strengthen the Quality of Research and Industry- Institute Relationship.
- 4. The Employers of the candidates admitted under the above category for part-time Ph.D. program must undertake to relieve the candidate to stay in the campus to enable the candidate to complete the course work and a Certificate from the Organization stating that adequate facilities (with details) are available at the Organization for carrying out the research work.
- 5. University will allot a Supervisor to the candidate. However, candidates may be permitted to have an external supervisor from his/her organization.
- 6. The candidates admitted under this category are governed by the applicable regulations of the University.
